Privacy Policy

I, Rucavanné van Wyk, operate this website, Word Upon Word (https://worduponword.net). This document informs you of my policies regarding the collection, use and disclosure of Personal Information I receive from users and subscribers of the website.

Information Collection and Use

Changes to This Privacy Policy


